We MUST Go to Court

Only a major court battle can bring back and save the great St. Lucie River. And only you can make it happen.

United, we can force state and federal authorities to stop the massive discharges from Lake Okeechobee that have degraded the St. Lucie to the point that it is a health hazard. Fish and other wildlife suffer, or leave.

Kids and grandkids are told to stay away. Water sports cease.

As expected, property values slide as a formerly pristine estuary is turned into a lifeless mudbath.

At the heart of the problem is Florida's Drainage Machine. This huge network of canals and control structures manipulates Lake Okeechobee water mainly for the benefit of the Everglades Agricultural Area. More than 500 billion gallons of turbid fresh water are discharged annually from the lake to ocean through the man-made St. Lucie Canal and to the west coast.

The Rivers Coalition Defense Fund intends to stop the large-scale discharges in the name of our citizens' basic right to enjoy clean water and the high quality of life that should go with a beautiful waterfront community.

But what exactly do you want?

Our focus is to halt the huge discharges made to the estuaries when Lake Okeechobee is allowed to reach excessive heights. The high water virtually destroys the lake's ecosystem as well as ruining the rivers.

Mow could they stop the big discharges?

A By maintaining the lake at a much, much lower level while making "trickle" releases year-around, much of the problem can be solved.

Even so, the water has to go somewhere, right?

Yes, and authorities must increase storage areas to retain more water. Once government makes a bonafide decision to stop the massive releases, there are many options in its "toolkit."

What about the "bold and aggressive Lake Okeechobee and Estuary Recovery plan" we've been hearing about?

A Unfortunately, the plan is neither bold nor aggressive and the planned projects are a re-hash of long-pending works that are too small to prevent the big discharges. Everything is designed to assure farmers of perfect drainage on property that was Mother Nature's wetlands, the River of Grass.

But now they say hurricanes and record rainfall caused our troubles.

A The truth is that the discharge assaults on our estuaries go back years before the storms. And last year's so-called record rains were only ten percent above average. Plus, some of our worst discharges occurred in under-average rain years.

Q Sometimes we see the river cleaning up. Does this mean we're recovering?

A No, the nasty water will hit us again as soon as the gates are opened more. Occasionally we do have some better times all right, but that's just a deceptive "calm eye in the discharge machine."

Well, since the Florida Constitution says the state "shall" keep the rivers clean, why haven't lawmakers been made to answer for this outrage?

A Sadly, it's very difficult to sue government, but the Rivers Coalition Defense Force, working with a nationally acclaimed legal team, believes it has grounds to require authorities to clean and protect the estuaries for the benefit of Florida citizens.
