- <u>State and Federal Agencies and Issues:</u> Dr. Paul Gray of Audubon: Lake O is over 2.' from this time last year. Brandon Tucker of SFWMD spoke of how there an emergency of high water and Martin County got hit the hardest. Caulkins Water Farm is working great. C-44 STA coming on line this year.
