June 6th 4:00 City of Stuart is having a workshop on plastics and has joined Martin County in regulations against single use plastics.

Lake O Report:

Dr. Paul Gray of Audubon said the eel grass is recovering and hopes the Lake stays below 11 feet.

LOSOM: Mark Perry said that the ACOE received more than 8,000 comments on LOSOM from the public. Alex Gillen spoke also.

Local Issues & Estuary Water Quality:

Mark Perry stated that the water quality of good. There is seagrass and oyster recovery. Thanks to the over 40 volunteers who weekly test the waters for FOS. FOS also voted against off-shore drilling.

Indian Riverkeeper Update:

Marty Baum stated that he has been Riverkeeper for over 7 years and he demanded that Lake O be cleaned to stop the algae from blooming. Marty had two speaking engagements, the Humanist Club and Pelican Island. There are two women interested in becoming riverkeepers for Mosquito Lagoon and Loxahatchee River.

Members Comments:

Mark Perry reminded people of World Ocean Day on June 8th. There will be oyster shell bagging events.

Alex Gillen warned not to be fooled by politicians saying how much money they got for Florida Forever, it wasn't as much as requested and some 50 million was rolled over from last year. To inflate the numbers.

Paul Laura made the motion to have the Rivers Coalition to write a letter of concern to our local State Rep.Toby Overdorf on his sponsorship of House Bill 771 (it was vetoed by Gov De Santis). Also ask Toby to attend the next RC meeting. Jackie Trancynger 2nd the motion. The motion was unanimously accepted. Jim Moir to write the letter and Mark Perry will sign it.

Hillarie Davis stated that the US Sailing Center of Martin County also has banned plastic straws, recycles, uses cornstarch utensils, and the student sailors compost their trash.
