Mark Perry called the meeting to order at 11:00 am. 74 people on ZOOM call Minutes taken by Miki Blumenthal, Administrative Assistant

#### **Presentation:**

**LOSOM Update by Eve Samples:** At meeting of Jan. 12th, the SFWMD asked for control of a larger swath of lake water. She showed the USACE's operations chart and indicated where the additional 1.5 buffer would be. FOE's main concern was the possible political pressure that could be put on SFWMD to keep lake levels higher during the dry season than is necessary. The lake plan is a 10-year plan, while the leadership of SFWMD changes with election cycles.

Jacqui Thurlow-Lippisch responded to various questions proposed by Eve, the main being one where and when the proposal had been generated. Her reply was that it was a communication problem and that the proposal had existed since July 2021, but no specifics had been discussed until recently. She passed the discussion over to Drew Bartlett, who replied that they were not trying to "add a line to the graph" but would continue discussions.

Col. Booth with USACE said they monitor Lake O for federal purposes, one of them being water supply. He said they are committed to continue working with SFWMD to draft operational policies and that there would be plenty of opportunity for further comments/communication. He went over the LOSOM schedule and said the next PDT would be sometime in mid-February.

#### Save the Manatee Club - Patrick Rose

Last year's manatee mortality rate was a record high of 1101 verified deaths. The trend is continuing this year (50 in January) due to cold stress and large-scale malnutrition leading to starvation. Patrick said around 20 manatees were trapped when the locks closed, and the USACE responded that they are aware and are heating the water for the manatees. Patrick said his club has rescue efforts underway and is providing supplemental feeding.

Patrick asked the SFWMD to review the removal of freshwater vegetation in canals because the manatees are going farther inland seeking food.

### SFWMD Update – Jacqui Thurlow-Lippisch

JTL talked about the C23/C24 groundbreaking ceremony scheduled for Feb. 18<sup>th</sup>. She said, "This is a magical time of progress." She mentioned that they are still working on the EAA reservoir and that it "has to happen."

Col. Kelly responded that the \$1.5 billion recently allocated to the USACE for Everglades Restoration is being used to fund projects that can be completed, whereas the EAA would require billions. He is confident the momentum will continue for the EAA.

### Seagrass Mitigation Bill HB 349 sponsored by Toby Overdorf

(Toby had to leave the meeting before this discussion due to another obligation.)

Mark Perry said a letter had been sent by the Rivers Coalition to Toby Overdorf and the other bill sponsors indicating why the RC is opposed to this bill.

Eve summarized the bill and why the RC members opposed it. The bill would make it easier for developers to get permits, and according to a leading seagrass expert in Florida, "the bill is bad for lots of reasons."

Mark Perry said that seagrass mitigation banking might sound like a good idea, but it is not, because it has been tried unsuccessfully in the past. He said RC would be tracking this closely.

Discussion: (summary of discussion-not verbatim)

**Government & Agency Reports:** 

Martin County: n/a

**City of Stuart/LOSOM**- Ben Hogarth said the city is focusing on legislation at this time and that they are working on their positions.

Mayor Matheson said that the lake levels are a direct reflection on the burden that the City of Stuart might bear in the rainy season. Staff is working on putting their position in writing. At the last city council meeting, they voted to apply for a matching grant for a living shoreline near the hospital.

**SFWMD**: Jacqui Thurlow-Lippisch said SFWMD's next meeting will be on Thursday, Feb 10<sup>th</sup> in West Palm Beach. She encouraged all to attend, stating that, "We have to keep fighting."

**USACE:** LTC Polk reviewed the operations slide and said their intent was to try not to release water. Regarding the manatees, he reiterated that they are working on heating the waters. He reassured all that the USACE is in constant communication with the SWFMD.

Lake O Update: Dr. Paul Gray not in attendance.

**State and Federal Legislation:** Eve referred to the seagrass mitigation bill and then asked Gil to discuss the other main legislation.

Gil Smart discussed SB1000/HB1245 about "rate tailoring" which allows farmers to hire consultants to recommend customized fertilizer rates, aimed primarily at the citrus industry. The additional fertilizer would naturally lead to more runoff. The consultants would be enrolled in BMPs, but currently the BMPs are not working as intended, because if enrolled, there is a presumption of compliance, with no monitoring. Gil said the only outcome would be more nutrients into the watershed. For more info, see everglades.org.
